Norway); Minquiers and Ecrehos Islets (United Kingdom v. France); Certain Frontier Land (Belgium v. Netherlands); and Temple of Preah Vihear (Cambodia v. Thailand), before the International Court of Justice. Historic Titles are probably also a relevant factor in a number of territorial disputes that have not yet been submitted to arbitration or judicial settlement. The recent controversies over the proper breadth for the territorial sea and the exclusive fishing limits of coastal States have brought to the fore new aspects of the problem.
